Partner-country Initiative Latvia – Germany 2025 - 2028

Mutual agreement

The Latvian library scene, represented by the *National Library of Latvia (Latvijas Nacionālā bibliotēka, LNB)* and the *Library Association of Latvia (Latvijas Bibliotekāru biedrība, LBB)* and the German library scene, represented by the umbrella association *Library & Information Germany (Bibliothek und Information Deutschland, BID)*, hereby agree on a closer exchange of interests in joint consultation for the period June 2025 - June 2028. The partner-country initiative applies to all types of libraries and library institutions.

The *National Library of Latvia* will act as the Latvian coordinating organisation for the project, and *BID* will also do the same for the German side.

Within the framework of the three-year partner-country phase, the following common goals are agreed upon:

- To strengthen the links between the Latvian and German library landscapes in the form of tangible joint achievements
- To intensify exchange and knowledge sharing between both professional communities
- To foster lasting, mutually beneficial relationships between institutions and individuals in both countries.

The partner associations *Library & Information Germany (BID)* and the *National Library of Latvia (LNB)* and the *Library Association of Latvia (LBB)* hereby agree upon the following:

A working group in both countries will coordinate and organise the different activities in its country; both groups will exchange regularly.

The partner-country initiative will be launched in summer 2025 in Germany. At the German national library congress in Bremen, organised by *BID*, the partner country Latvia will be integrated into the congress programme in various ways in order to introduce itself to the German professional public and to draw attention to the launch of this initiative. Participation details will be jointly agreed by both parties.

During the three partnership years, various activities are planned:

- Regular reports on current topics of the respective other country in professional publications (online, social media and print)
- Joint discussion on various current topics in the form of lectures, online seminars, joint events (i.e., 'German-Latvian dialogue on the future of libraries')

- Personal exchanges in the form of study trips to the respective other country, joint study trips to third countries, online exchanges, professional stays
- 'Librarian in Residence' (LiR). LiR is an annual scholarship for a residence programme. It applies to a specialist stay in the respective partner country. It always follows a specific annual issue. It gives library community experts an intensive insight into how respective questions are dealt with conceptually and practically in the respective partner country.
- To make the Partner Country Initiative visible and to give the various activities a visual framework, a logo will be designed which follows the corporate design of the previous partner-countries with Germany.

The archive on the activities of the partner-country initiative will be located on the German side at www.bi-international.de. On the Latvian side, this will be done via biblioteka.lv and bibliotekari.lv: all will be linked.
